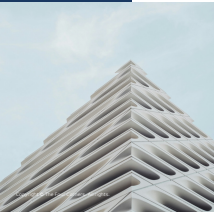
The Team

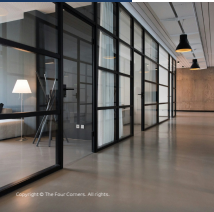
08 Economic Growth & Investment Opportunities
